THE FORESTS ORDINANCE

THE SEMENGGOH FOREST RESERVE (REVOCATION) NOTIFICATION, 2000

(Made under section 24)

In exercise of the powers conferred upon the Minister by section 24 of the Forests Ordinance (*Cap. 126 (1958 Ed.)*), the following Notification has been made:

1. This Notification may be cited as Semenggoh Forest Reserve (Revocation) Notification, 2000.

2. It is hereby directed that the area of the land described in the Schedule, being part of the Semenggoh Forest Reserve as constituted under *Gazette* Notification No. CXX dated 15th November, 1920, shall be ceased to be a forest reserve, with effect from 17th February, 2000.

SCHEDULE

Name : Semenggoh Forest Reserve.
 Division : Kuching.
 District : Kuching.
 Area : 653 hectares approximately.
 Boundary : Commencing at Land and Survey Peg No. 1/553 on the right side of the old Kuching-Penrissen Road, the boundary proceeds generally in a northwesterly direction by lines whose bearings and distances are stated below; until it meets a portion of Landeh Road in the north.

From there, the boundary proceeds in a westerly direction by cut lines at bearing 268° 00' for 200 metres, 270° 00' for 160 metres, 272° 30' for 200 metres, 272° 30' for 266 metres and 275° 00' for 200 metres.

Thence, it follows cut lines southwardly by the following bearings and distances:

The boundary proceeds in an easterly direction by a straight line 93° 00' for 1410 metres till Sg. Semenggoh, then another 276 metres along the river bank, thence by the following bearings and distances.
