THE NATIONAL PARKS AND NATURE RESERVES ORDINANCE, 1998

THE USUN APAU NATIONAL PARK NOTIFICATION, 2005

(Made under section 19(1))

Pursuant to section 19(1) of the National Parks and Nature Reserves Ordinance 1998 [Cap. 27], the Minister of Planning and Resource Management has made the following Notification:

- 1 This Notification may be cited as the Usun Apau National Park Notification, 2005.
- The land described in the First Schedule shall with effect from 18th May, 2005, be constituted as a National Park, which shall be known as the Usun Apau National Park.
- 3. The rights and privileges conceded within the National Park shall, subject to section 19 of the National Parks and Nature Reserves Ordinance 1998 [Cap. 27], be those a listed in Second Schedule and enjoyed or exercised by the residents of the longhouses named in that Schedule.

FIRST SCHEDULE

Name

Usun Apau National Park.

Division

Miri

49 355 hectares approximately

Boundaries In this account, grid reference and distances are approximate only and the demarcated boundary shall be considered correct. All grid references refer to Netherland East Indies Grid (metres) Equatorial zone, in the Sarawak map series 1735, edition 1-GSGS.

Commencing at (1), the confluence of Sg. Dapoi and Sg. Tabalau upstream in a southerly direction for 4180 metres to (2), a point on the Kapit/Miri Divisional boundary; thence along this watershed in an easterly direction, passing through a few mountain peaks including Bukit Selidang, for 18 900 metres to (3); thence turns away from the watershed to follow the source of a unnamed stream downstream in North-Easterly direction for 7990 metres to meet its confluence with Sg. Selio (4); thence along the true left bank of Sg. Selio downstream for 6470 metres to (5); thence turns away from the sungai to follow a series of cut lines bearing 0° 45' for 1960 metres (6); 97° 30' for 5970 metres (7); 4° 30' for 3400 metres (8); 317° 45' for 22 890 metres (9); 268° 30' for 13 520 metres (10); 349° 45' for 125 metres to a point on Sungai Dapoi (11); thence along the true right bank of Sungai Dapoi upstream in a southerly direction for 23 240 metres to come back to the point of commencement.

The insertion boundary description as shown below is to be excluded from the Usun Apau National Park (405 ha).

Commencing from a point ref: (003° 01 44"; E114° 28' 41") on the river bank of Sungai Julan, the boundary follows a series of cut bearing 90° 00' for 2100 metres; 180° 00' for 2000 metres; 270° 00' for 1500 metres to meet Sungai Julan at (N 003° 00' 38". E114° 39' 00"); thence follows the true right of Sungai Julan downstream for 2680 metres to come back to the point of commencement.

Note. 1 Bearing and distances are approximate only, and the demarcated boundary shall be considered correct.

Note. 2. Land held under any issued document of title is to be excluded from the National Park except where agreement has been reached with the title holders for inclusion of their Land in the National Park.

SECOND SCHEDULE

- (I) The inhabitants of the longhouses of (a), (b) and (c) below under the jurisdiction of Marudi District:
 - * Shall have the privilege of collecting the minor forest produce such as leaves, rattan, roots and medicinal plants for their own consumption but not for sale.

- * Shall have the privileges of hunting animals which are not listed as totally protected and protected animals between the hours of 6 a.m. to 6 p.m. for their own consumption but not for sale.
- (a) The inhabitants of the longhouses below shall have the privileges of (I) above, within the Sg. Julan and its tributaries up to Sg. Julan water falls.

The longhouses are:

1 Long San 5 Long Anap
2. Long Selatong Kanan 6. Long Julan
3. Long Selatong Kiri 7 Long Pelutan
4. Long Apu 8. Long Palai

(b) The inhabitants of the longhouses below shall have the privileges of (I) above, within the Sg. Selio (N 2° 51 33"; E114° 45' 00") and its tributaries up to no named river (N 2° 51 08"; E114° 42' 08") for a distance of 6.47 km from the boundary of the park.

The longhouses are:

1 Long Jeeh 5 Long Jekitan
2. Long Belaong 6. Long Tikan
3. Long Moh 7 Long Bee
4. Long Mekaba 8. Ba'Purau

(c) The inhabitants of the longhouses below shall have the privileges of (I) above, within the Sg. Dapoi (N 3° 0' 46"; E114° 32' 48") and its tributaries up to confluence of Sg. Dapoi and Sg. Silat (N 3° 3' 10"; E114° 32' 52") for a distance of 6.4 km from the boundary of the park.

The longhouses are:

1 Long Lobang 5. Long Krong 2. Long Puah 6. Long Liaw

3. Long Buken

- (II) The inhabitants of the following longhouses of (a) below under the jurisdiction of Belaga District:
 - * Shall have the privileges of collecting the minor forest product such as leaves, rattan, roots and medicinal plants for their own consumption but not for sale.
 - * Shall have privileges of taking fish with traditional methods for their own consumption but not for sale.
 - * Shall have the privileges of hunting animals which are not listed as totally protected and protected animals between the hours of 6 a.m. to 6 p.m. for their own consumption but not for sale.
